

# VAD TERMS VAD Rebate: Wing Express Access Point Giveaway Program

With the new WiNG Express access point, small to mid-sized businesses finally have the high performance, enterprise-class wireless networking they need to better compete, boost operational efficiency and deliver best-in-class customer service. The WiNG Express Access Point Giveaway Program empowers distributors to assist Zebra Technologies in driving awareness and adoption of WiNG Express in both the end-user and reseller communities. As part of this program, VADs are reimbursed for each AP6521-E access point given to qualifying resellers or customers at no cost.



## **PROGRAM OVERVIEW**

REBATE PERIOD	June 1, 2015 – August 31, 2015
ELIGIBILITY	All PartnerEmpower Value-Added Distributors in North America ("Distributor(s)")
REBATE	Distributors shall receive a rebate ("Rebate") for the full price they are invoiced by Zebra Technologies on every AP6521-E access point and related power option (PWRS-14376-01R) given away for free as part of the WiNG Express Access Point Giveaway Program ("Giveaway").
	The Giveaway is only valid after the initial 20 units previously provided to VADs under Phase 1 of this program have been fully utilized.
	Other than the power option PWRS-14376-01R, the Rebate does not apply to accessories or services associated with the AP6521-E.
REBATE PROCESS	The Giveaway is only available through Distributors. Free access points may be made available to:
	<ul> <li>Resellers, including new or existing PartnerEmpower resellers, or Open Resellers ("Reseller Company(ies)").</li> <li>Distributors shall identify Reseller Company candidates who can qualify based upon the criteria below.</li> </ul>
	<ul> <li>Customers / prospects ("End-user Company(ies)"). Resellers shall identify End-user Company candidates who can qualify based upon the criteria below, and request a free unit from the Distributor.</li> </ul>
	To receive the Rebate for the free unit, Distributors must provide the name of the Reseller Company or End-user Company that received the free access point, along with the appropriate promotion code, on Sales Out reports.

	Promotion Code for End-User Company units: NAEXPPRESSENDUSER
	Distributors will receive a monthly reimbursement within 45 days of the end of each calendar month after reporting.
RESELLER QUALIFICATION BY DISTRIBUTOR	Distributors are responsible for qualifying Reseller Companies, using the following Reseller Participation Criteria, prior to providing free access points.
	Reseller Participation Criteria
	<ul> <li>Reseller Company must be a valid North America business focused on WLAN, offering access points, routers, Ethernet switches and services to be eligible for the Giveaway.</li> </ul>

	• Reseller Company must have an installed customer base of wireless infrastructure and services generating a minimum of \$50K revenue per year.
	• The free access points will be delivered by the Distributor to a Reseller Company Representative having a valid corporate email address. Reseller Representatives using a personal email address (i.e., Gmail or Yahoo) are disqualified from the Giveaway. Reseller Company must have customers or prospects for which WiNG Express is a viable solution. Opportunity pipeline should be quantified or presented to the Distributor.
	Reseller Company does not need to be a PartnerEmpower member.
	PartnerEmpower Distributors and Application Partners do not qualify for the Giveaway.
	Limit one (1) free access point per Reseller Company.

END-USER QUALIFICATION BY RESELLER	<b>Resellers</b> Companies are responsible for qualifying End-users Companies prior to providing a free access point using the following criteria. <b>Distributors should work with Reseller Companies to ensure full understanding of the criteria and qualification process</b> .
	End-User Participation Criteria
	• End-user Company must be a valid North American business with more than 50 employees at a single site to be eligible for the Giveaway.
	• End-user Company must have a Wireless LAN project planned in the next six (6) months with five (5) or more access points with implementation planned in the U.S. or Canada.
	• The free access points will be delivered by the Reseller Company to an IT professional at the End-user Company having a valid corporate email address. IT professionals using a personal email (i.e., Gmail or Yahoo) are disqualified from the Giveaway.
	• If End-user Company cannot accept a free access point due to restrictions, (e.g. Erate), a trial access point, which can be returned following evaluation of the solution, will be provided.
	PartnerEmpower Distributors and Application Partners do not qualify for the Giveaway.
	• Limit one (1) free access point per End-user Company.
	No purchase necessary.

## **DISTRIBUTOR TERMS**

#### Rebate Period: Sept. 1, 2014 - August 31, 2015

- The Rebate offered by Zebra Technologies under the Giveaway applies only to AP6521-E access points and the associated power option PWRS-14376-01R provided to Reseller Companies or End-user Companies in accordance with the Giveaway.
- 2. Distributors must qualify a Reseller Company based upon the criteria above before providing the free access point to Reseller Companies. Distributors must ensure that all necessary end-user information is provided before their Resellers provide a free access point to an End-user Company.
- 3. The Rebate shall be provided for access points shipped by Distributors as part of the Giveaway to Resellers, for their eligible End-user Companies, no later than 30 days after the conclusion of the Rebate Period.
- 4. Product supply during the Rebate Period is subject to availability.
- 5. The Rebate does not apply to accessories or services associated with the AP6521-E, other than the power option PWRS-14376-01R.
- 6. Distributors must provide the following promotion code on Sales Out for each particular transaction:
  - **Promotion Code for Reseller units:** NAEXPRESSVAR
  - Promotion Code for End-User units: NAEXPPRESSENDUSER
- 7. Sales Out reports must be submitted in accordance with Sales Out Compliance Guidelines and include Reseller Company or End-user Company names, country, and zip code information.
- 8. Zebra Technologies and its agents have the right to audit, validate or verify any purchases/sales claimed and serial numbers submitted.
- 9. Zebra Technologies reserves the right to modify, withdraw or cancel the Rebate (in whole or in part) at any time and/or in any geography for any reason or for no reason, without prior notice.

- 10. Any requests that do not comply with the terms of the Rebate will be rejected. The Rebate is subject to all local laws and regulations.
